# Privacy Notice – UK Biobank (COVID-19 Update)

#### Plain English explanation

UK Biobank is a large-scale biomedical database and research resource, containing in-depth genetic and health information from UK participants. It is accessible to approved researchers undertaking vital research into the most common and lifethreatening diseases. More information can be found at <a href="https://www.ukbiobank.ac.uk">ukbiobank.ac.uk</a>.

Due to the unprecedented challenges that the NHS face due to the worldwide COVID-19 pandemic, there is a greater need for public bodies to require additional collection and sharing of personal data to protect against serious threats to public health.

The Secretary of State has served notice under Regulation 3(4) of the <u>Health</u> <u>Service (Control of Patient Information) Regulations 2002 (COPI)</u> to require organisations to process confidential patient information in the manner set out below for purposes set out in Regulation 3(1) of COPI.

#### **Purpose of this Notice**

The purpose of this Notice is to require organisations such as Eleanor Cross Healthcare to process relevant primary care data to UK Biobank for purposes related to the outbreak for COVID-19. "Processing" for these purposes is defined in Regulation 3(2) and includes sharing of confidential patient information to persons and organisations permitted to process confidential patient information under Regulation 3(3) of COPI.

### Requirement to Process Confidential Patient Information

Eleanor Cross Healthcare is only required to process such confidential patient information:

- where the confidential patient information to be processed is required for a Covid-19 Purpose and will be processed solely for that Covid-19 Purpose in accordance with Regulation 7 of COPI
- where the patent information is relating to a UK Biobank consented participant
- from 20<sup>th</sup> March 2020 until 30th September 2021.

#### Covid-19 Purpose

A Covid-19 Purpose includes but is not limited to the following:

- understanding Covid-19 and risks to public health, trends in Covid-19 and such risks, and controlling and preventing the spread of Covid-19 and such risks
- identifying and understanding information about patients or potential patients with or at risk of Covid-19, information about incidents of patient exposure to Covid-19 and the management of patients with or at risk of Covid-19 including: locating, contacting, screening, flagging and monitoring such patients and collecting information about and providing services in relation to testing, diagnosis, self-isolation, fitness to work, treatment, medical and social interventions and recovery from Covid-19
- understanding information about patient access to health services and adult social care services and the need for wider care of patients and vulnerable groups as a direct or indirect result of Covid-19 and the availability and capacity of those services or that care
- monitoring and managing the response to Covid-19 by health and social care bodies and the Government including providing information to the public about Covid-19 and its effectiveness and information about capacity, medicines, equipment, supplies, services and the workforce within the health services and adult social care services
- delivering services to patients, clinicians, the health services and adult social care services workforce and the public about and in connection with Covid-19, including the provision of information, fit notes and the provision of health care and adult social care services
- research and planning in relation to Covid-19.

### Review and Expiry of this Notice

This Notice will be reviewed on or before 30 September 2021 and may be extended by The Secretary of State. If no further notice is sent to Eleanor Cross Healthcare by The Secretary of State this Notice will expire on 30 September 2021.

5) Recipient or categories of recipients of the processed data 6) Right to	diagnosis, the provision of health or social care or treatment or the management of health or social care systems and services".  We will also recognise your rights established under UK case law collectively known as the "Common Law Duty of Confidentiality"*.  The Secretary of State has served notice to recipients under Regulation 3(4) of COPI that requires Eleanor Cross Healthcare to process confidential patient information, including disseminating to a person or organisation permitted to process confidential patient information under Regulation 3(3) of COPI.  The Secretary of State has issued notice under COPI requiring the following organisations to process information:  - UK Biobank.
object	You should be aware that this is a right to raise an objection, that is not the same as having an absolute right to have your wishes granted in every circumstance.
7) Right to access and correct	You have the right to access the data that is being shared and have any inaccuracies corrected. There is no right to have accurate medical records deleted except when ordered by a court of Law.
8) Retention period	The data will be retained in line with the law and national guidance. <sup>\* &</sup>quot;Common Law Duty of Confidentiality", common law is not written out in one document like an Act of Parliament. It is a form of law based on previous court cases decided by judges; hence, it is also referred to as 'judge-made' or case law. The law is applied by reference to those previous cases, so common law is also said to be based on precedent.

The general position is that if information is given in circumstances where it is expected that a duty of confidence applies, that information cannot normally be disclosed without the information provider's consent.

In practice, this means that all patient information, whether held on paper, computer, visually or audio recorded, or held in the memory of the professional, must not normally be disclosed

without the consent of the patient. It is irrelevant how old the patient is or what the state of their mental health is; the duty still applies.

Three circumstances making disclosure of confidential information lawful are:

- where the individual to whom the information relates has consented;
- where disclosure is in the public interest; and
- where there is a legal duty to do so, for example a court order.
