Privacy Notice – NHS Health Checks

Plain English explanation

NHS Health Check is a scheme which provides a health check-up for adults in England aged 40 to 74. This health check can spot early signs of stroke, kidney disease, heart disease, type 2 diabetes or dementia. Eleanor Cross Healthcare participates in this scheme.

This practice keeps data on you including personal information and the information about health and social care you received from us and other organisations who were involved in your health care.

We apply searches and algorithms to your data in order to identify individuals who are able to participate in NHS Health Check scheme.

We use a software which allows us to categorise patients according to risk levels. It also allows Public Health Northamptonshire to view pseudomised information for the purpose of scheme uptake and payment.

The processing of this data occurs outside the practice, but your identity is not visible to the processors. Only this practice is able to identify you and the results of any calculated factors.

You have the right to object to our sharing your data in these circumstances but we have an overriding responsibility to do what is in your best interests.

^{* &}quot;Common Law Duty of Confidentiality", common law is not written out in one document like an Act of Parliament. It is a form of law based on previous court cases decided by judges; hence, it is also referred to as 'judge-made' or case law. The law is applied by reference to those previous cases, so common law is also said to be based on precedent.

The general position is that if information is given in circumstances where it is expected that a duty of confidence applies, that information cannot normally be disclosed without the information provider's consent.

In practice, this means that all patient information, whether held on paper, computer, visually or audio recorded, or held in the memory of the professional, must not normally be disclosed without the consent of the patient. It is irrelevant how old the patient is or what the state of their mental health is; the duty still applies.

Three circumstances making disclosure of confidential information lawful are:

- where the individual to whom the information relates has consented;
- where disclosure is in the public interest; and
- where there is a legal duty to do so, for example a court order.
